Insurance

All hirers are required to have <u>Public Liability Insurance</u> with indemnity for \$20m. Evidence of Insurance must be supplied prior to approval of hire.

Security and Incidents

Please ensure your group understands the emergency evacuation procedure. **In an emergency, phone 000.** Coastcom Security manage the Centre (1300 844 844); your group will be charged for call out costs.

Security ratio is 1/100 people; in the event that a Hirer is required to arrange security personnel or Victorian Police to be in attendance at any time, only licensed security personnel are permitted and their security numbers are to be displayed during period of hire.

Care for your Health and Safety

Please follow health and safety standards. <u>Spills must</u> be immediately cleaned up to prevent accidents (cleaning can be arranged for \$50 per hour); watch for <u>overcrowding</u> and obstruction of passages or entry ways. <u>Smoke machines</u> are prohibited due to fire detection devices.

A <u>First Aid kit</u> is available in the kitchen, and an <u>AED</u> in the foyer. For your protection, for large gatherings, we strongly advise having a qualified First Aider available.

Condition of Premises

The hirer is responsible for any damages or losses incurred to equipment or property. When leaving, please act responsibly and vacate at the time arranged.

Consider those **coming in after you, and return the room to its original state**. As a Community Centre, we keep Hiring Fees low to make the Centre accessible to as many people as possible. We work on a self-help basis – we do not have cleaning staff every day, nor do we have staff to set up/take down rooms for you.

Please clean as much as possible, and empty all bins into the external rubbish bins (ready for pick up by Council). If left dirty, a security bond/fee may be required for additional cleaning, damage, etc.

Times and Noise

All persons must have left the premises by <u>11.30pm</u> due to residential zoning. The State Environment Protection Policy Section 2 (https://www.epa.vic.gov.au) sets out acceptable noise levels. Amplified music should not be heard in properties adjoining the Reserve after 11.00pm (10.00pm on Sundays). If the noise exceeds these times, the Police may be called. Users must give due notice to the amenity in the area.

Smoking, Gambling and Alcohol

<u>Smoking</u> is not permitted inside the building or around the entrances. No <u>game of chance</u>, at which either directly or indirectly money is passed as a prize is permitted. If <u>alcohol</u> is to be sold or included in the price of entry, the Hirer must: (a) check the appropriate permit - Liquor Licensing Vic (https://www.vcglr.vic.gov.au/), (b) provide a copy of a Liquor Licence to SCC to endorse the Hiring application. No alcohol is to be served after <u>11.00pm</u>.

Being Environmentally Responsible

We work hard to keep our hiring rates affordable for you. We look to you, the Hirer, to turn off lights, heating/cooling, to save power and costs.

Animals

Animals are not permitted in the Centre with the exception of Guide Dogs or Companion Dogs. Special approval is needed for pet events or expos.

Child Safety

Victorian Child Safe policies require that when children are involved in activities without their parents, Hirers or their staff must hold a current Working with Children Check.

Refusal to Let

Hirers must be <u>21 years and over</u> and must be in attendance at all times at events where the majority of attendees are under 21 years. Facility Hire is at the discretion of the SCC Board who may refuse to let the facilities to individual or group; their decision is final.

Code Red Days

Sorrento Centre cannot be used on Code Red days and staff will not be available. Please ensure you have made alternative arrangements in the event of hot weather or storms.
